

AN ORDINANCE AMENDING PARAGRAPH 9, SECTION 1139-d, RULE IV, OF THE COMPILED ORDINANCES OF THE CITY OF MANILA, AS LASTLY AMENDED BY ORDINANCE NO. 4224, SO AS TO INCLUDE DAKOTA STREET AS A "THRU STREET".

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. Paragraph 9, Section 1139-d, Rule IV, of the Compiled Ordinances of the City of Manila, as lastly amended by Ordinance No. 4224, is hereby further amended to read as follows:

"Par. 9. All vehicles traversing or crossing the following through streets:

Cabildo; 15. Canonigo; 16. Carriedo; 17. Colgante Ext. or Quezon Blvd.; 18. Concepcion; 19. Depitan; 20. Dasmariñas; 21. Dewey Blvd.; 22. Dimasalang; 23. Echague; 24. Escolta; 25. España; 26. Gen. Luna from Taft to Celifornia; 27. Gen. Solano; 28. Gonzalo Tuzon; 29. Gov. Forbes; 30. Harran from Mabini to Wright, and from Pennsylvania to P. Sta. Ana; 31. Harrison Blvd.; 32. Isaac Peral from Alhambra to Florida, and from San Marcelino to Canonigo; 33. Juan Luna; 34. Katigbak Drive; 35. Legarda; 36. Madrid; 37. Magallanes Drive; 38. Magdalena; 39. M. Earnshaw; 40. M. H. del Pilar; 41. M. Clara; 42. Mandiola; 43. M. de San Francisco; 44. North Bay Blvd.; 45. Croquieta; 46. Otis; 47. P. Burgos; 48. Real; 49. R. Hidalgo; 50. Rosario; 51. Saade; 52. San Andres; 53. SEC. 2. This Ordinance shall take effect upon its approval.
