

ORDINANCE NO. 4597

AN ORDINANCE AMENDING GROUPS 4 TO 8 OF SECTION 1 OF ORDINANCE NO. 1925 AS LASTLY AMENDED BY ORDINANCE NO. 3364 BY PROVIDING NEW CLASSIFICATIONS AND RATES OF LICENSE FEES ON THE DIFFERENT BUSINESSES ENUMERATED THEREIN.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. Groups 4 to 8 of Section 1 of Ordinance No. 1925, as lastly amended by Ordinance No. 3364, are hereby further amended to read as follows:

"Group 4. The following manufacturers likewise are subject to the payment of the municipal license fees in accordance with the rates as indicated herein below:

Manufacturers of embroideries; ropes, papers; harness or valises, bags or any of them; textiles, shell lamps or lamp shades or both; men's shirts bottles or glasswares or both; buttons, nails and fertilizers:

PROVIDED, That this group shall include establishments or stores for the sale of slippers which are made in factories or their agencies located in the City of Manila or elsewhere, and the sellers of men's suits (made to order or ready made); AND PROVIDED, FURTHER, That the license fee on tailor shops shall be based not on the sale of cloth that are necessarily connected with the business, but on the principal object of the business which is tailoring, so that tailor shops shall pay the license fee corresponding to tailor shop and not as dealers in cloth."

SEC. 2. This Ordinance shall take effect on July 1, 1962.
