

AN ORDINANCE APPROPRIATING THE AMOUNT OF P3,417,545.51 TO BE MADE AVAILABLE FOR THE PURCHASE OF TEXTBOOKS AND SUPPLEMENTARY READERS TO BE LOANED FREE OF CHARGE TO PUPILS AND STUDENTS IN THE INTERMEDIATE GRADES AND IN THE CITY HIGH SCHOOLS, UNDER CERTAIN CONDITIONS.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of P3,417,545.51, or so much thereof as may be necessary, is hereby appropriated out of any funds existing in the City Treasury not otherwise appropriated to be made available for the purchase of the following textbooks to be loaned free of charge to pupils and students in the intermediate grades and in the City High Schools, to wit:

SEC. 2. The Superintendent of City Schools is hereby authorized to purchase the herein textbooks not to exceed the estimated prices as per itemized list of the textbooks, enclosed in a list Indorsement dated June 6, 1962, as amended on June 14, 1962, submitted by the Division of City Schools and approved by the Municipal Board; PROVIDED, HOWEVER, that the Superintendent of City Schools shall, one year from the date of the approval of this Ordinance, submit to the Municipal Board a list of all textbooks purchased with the corresponding prices therefor; AND PROVIDED, FURTHER, that whatever amount is not spent for the purpose herein mentioned one year from the date of approval of this ordinance be reverted to the general fund.

SEC. 3. This ordinance shall take effect upon its approval.
