

AN ORDINANCE AUTHORIZING A NEW REORGANIZATIONAL SET-UP IN THE IMMEDIATE OFFICE OF THE MAYOR, THRU THE CONVERSION AND/OR ASSIGNMENT OF CERTAIN POSITION-ITEMS; CREATING CERTAIN POSITIONS THEREAT; AND APPROPRIATING FUNDS NEEDED THEREFOR.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. A new reorganizational set-up in the immediate Office of the Mayor is hereby authorized.

SEC. 2. The amount of P5,499.99, or so much thereof as may be necessary, is hereby appropriated out of any funds existing in the City Treasury not otherwise appropriated to be made available for the increase in salary and the creation of the following positions under the Office of the Mayor, covering the period from May 15 to June 30, 1962:

- 1. One (1) Executive Technical Adviser to the Mayor from P10,000 p.a. to P12,000 p.a. ... P 249.99
  - 2. One (1) Senior Technical Assistant at P0,400 p.a. .... 1,050.00
  - 3. One (1) Technical & Management Consultant at P7,200.00 p.a. .... 960.00
  - 4. One (1) Technical Assistant on Public Health, Hygiene & Sanitation at P6,600 p.a. .... 825.00
  - 5. One (1) Technical Assistant on Fiscal Matters at P6,600 p.a. .... 825.00
  - 6. One (1) Technical Assistant on Protective Services at P6,600 p.a. .... 825.00
  - 7. One (1) Technical Assistant on Legislative & Public Affairs at P6,600 p.a. .... 825.00
- Total - P5,499.99

SEC. 3. The conversion and/or re-assignment of the following items existing in the appropriation of the Office of the Mayor under Appropriation Ordinance No. 4378, in accordance with the reorganizational set-up authorized under Section 1 hereof, is hereby effected as follows:
