

AN ORDINANCE AMENDING SECTION 995 OF THE COMPILATION OF THE ORDINANCES OF THE CITY OF MANILA, AS LASTLY AMENDED BY ORDINANCE NO. 3648, REFERRING TO ANIMALS UNLAWFUL TO KILL; AND FOR OTHER PURPOSES.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. Section 995 of the Compilation of the Ordinances of the City of Manila, as lastly amended by Ordinance No. 3648, is hereby further amended to read as follows:

"SEC. 995. Animals unlawful to kill. - It shall be unlawful to kill any cattle, carabao, buffalo, horse, mule, pig, sheep, goat, deer or any four-footed animal or fowls outside of the public slaughterhouse of the City of Manila, or to sell or offer or expose for sale, or to conceal, or harbor the carcasses or meat, or parts thereof, cooked or uncooked, within the jurisdiction of the City of Manila: PROVIDED, That all meats or parts thereof furnished from animals slaughtered and inspected in any national abattoir duly covered by a certificate of ante-mortem and post-mortem inspection of a veterinarian of the Bureau of Animal Industry shall only be brought for sale within the jurisdiction of the City of Manila in whole quarters or carcasses subject to inspection and verification at the City Slaughterhouse by the inspectors of the Meat Inspection Board: PROVIDED, FURTHER, That no fee whatsoever shall be charged and collected: AND PROVIDED, FINALLY, That said meats and carcasses or parts thereof shall be transported by vehicles duly registered and approved by the Meat Inspection Board."

SEC. 2. Any person, firm corporation, company, association or agent thereof violating any of the provisions of this Ordinance shall, upon conviction, pay a fine of not less than fifty pesos (P50.00) and not more than two hundred pesos (P200.00) and by imprisonment of not more than one (1) month.

SEC. 3. Repealing Clause - All ordinances of the City of Manila or parts thereof inconsistent with this ordinance are hereby repealed.

SEC. 4. This ordinance shall take effect upon its approval.

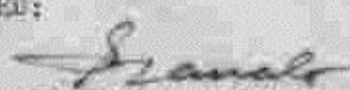
