

AN ORDINANCE AUTHORIZING THE INCREASE IN THE SALARIES OF CERTAIN POSITIONS IN THE APPROPRIATIONS OF THE MANILA FIRE DEPARTMENT UNDER ORDINANCE NO. 4566, ALL EFFECTIVE AS OF JULY 1, 1962; AND APPROPRIATING FUNDS NEEDED THEREFOR.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The increase in the salaries of the following positions in the appropriation of the Manila Fire Department under Ordinance No. 4566 be authorized, as it is hereby authorized, to wit:


SEC. 3. This Ordinance shall take effect as of July 1, 1962.


