

AN ORDINANCE AUTHORIZING THE CREATION OF CERTAIN POSITIONS AND FOR EXPENDITURES IN THE MANILA FIRE DEPARTMENT AND APPROPRIATING FUNDS NEEDED THEREFOR, FROM JANUARY 1, 1963 TO JUNE 30, 1963, INCLUSIVE.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The creation of the following positions in the Manila Fire Department, with compensations indicated hereunder, effective as of January 1, 1963 is hereby authorized, to wit:

TOTAL .....	<u>P 50,000.00</u>



The amount of P183,200.00, or so much thereof as may be necessary, is hereby appropriated out of any funds existing in the City Treasury not otherwise appropriated to be made available for the payment of the salaries of the positions created in Section one and for the expenditures mentioned in Section two hereof.


