AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱64,661.34 TO BE MADE AVAILABLE AS ADDITIONAL APPROPRIATION TO COVER THE REFUND OF MEAT INSPECTION FEES COLLECTED PURSUANT TO ORDINANCE NO. 2291 WHICH WAS DECLARED ILLEGAL BY THE SUPREME COURT.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of ₱64,661.34, or so much thereof as may be necessary, is hereby appropriated out of any funds existing in the City Treasury not otherwise appropriated to be made available as additional appropriation to cover the refund of meat inspection fees collected pursuant to Ordinance No. 2291 which was declared illegal by the Supreme Court, itemized as follows:
