

AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱186,150.00 (₱185,150.00 FOR THE VALUE OF THE LOTS AND ₱1,000.00 FOR MISCELLANEOUS EXPENSES) TO BE MADE AVAILABLE FOR THE ACQUISITION OF PORTIONS OF THREE (3) LOTS OWNED BY MR. BENEDICTO PADILLA, AFFECTED BY THE WIDENING OF GLOBO DE ORO, GASTAMBIDE, JUAN LUNA AND ILAYA STREETS, AT THE RATES OF ₱500.00, ₱250.00 AND ₱1,200.00 PER SQUARE METER, RESPECTIVELY, AS RECOMMENDED BY THE APPRAISAL COMMITTEE.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of ₱186,150.00, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury to be made available for the acquisition of portions of three (3) lots owned by Mr. Benedicto Padilla, affected by the widening of Globo de Oro, Gastambide, Juan Luna and Ilaya Streets, at the rates of ₱500.00, ₱250.00 and ₱1,200.00 per square meter, respectively, as recommended by the Appraisal Committee, itemized as follows:

1. For portion of lot at Barbosa Street and Globo de Oro Street - 100.9 square meters at ₱500.00 per square meter .....	₱50,450.00
2. For portion of lot at Gastambide Street - 32.4 square meters at ₱250.00 per square meter .....	8,100.00
3. For portion of lot at Ilaya-Juan Luna Streets - 105.5 square meters at ₱1,200.00 per square meter .....	<u>126,600.00</u> ₱185,150.00
4. For miscellaneous expenses .....	1,000.00
