AN ORDINANCE APPROPRIATING THE AMOUNT OF P60,000.00 TO BE MADE AVAILABLE FOR THE MAINTENANCE AND OPERATION OF TEN (10) NIGHT CLASSES (FIRST YEAR - 5 CLASSES, SECOND YEAR - 3 CLASSES AND THIRD YEAR - 2 CLASSES) AT RAJAH SOLIMAN HIGH SCHOOL FOR THE SCHOOL YEAR 1965-1966.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of P60,000.00, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury to be made available for the maintenance and operation of ten (10) night classes (First Year - 5 classes, Second Year - 3 classes and Third Year - 2 classes) at Rajah Soliman High School for the school year 1965-1966, itemized as follows:

- 1. Salary of one (1) Principal at P14.00 a night for ninety-nine (99) nights (three (3) nights a week) P 1,386.00
 - 2. Salary of one (1) Assistant Principal at P10.00 a night for ninety-nine (99) nights (three (3) nights a week) 1,039.50
 - 3. Salary of one (1) Guidance Counselor at P6.00 a night for sixty-eight (68) nights (two(2) nights a week) 408.00
 - 4. Salaries of fifty (50) Teachers at P2.70 per period each for eighteen thousand thirty-two (18,032) teaching periods (ninety-two (92) periods a night for one hundred ninety-six (196) nights) 48,686.40
 - 5. Salaries of two (2) Teachers at P5.00 a night each for ninety-nine (99) nights (three (3) nights a week) 990.00
 - 6. Salary of one (1) Librarian at P5.00 a night for ninety-nine (99) nights (three (3) nights a week) 495.00
 - 7. Salary of one (1) Janitor for one (1) year 2,160.00
 - 8. Supplies and materials 1,000.00
 - 9. Lighting materials 435.10
- T o t a l - - - - - P56,600.00

SEC. 2. This Ordinance shall take effect upon its approval.
