

AN ORDINANCE AUTHORIZING THE CONVERSION OF THE SINGALONG READING CENTER INTO A REGULAR BRANCH OF THE MANILA CITY LIBRARY; AND APPROPRIATING THE AMOUNT OF P28,000.00 FOR THE PURPOSES.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The conversion of the Singalong Reading Center into a regular branch of the Manila City Library, is hereby authorized.

SEC. 2. The amount of P28,000.00, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury to be made available for the purpose mentioned in Section 1 hereof, itemized as follows:
