**EXECUTIVE ORDER NO. 13**  
Series of 2022

**ORGANIZATION AND COMPOSITION OF THE CITY DEVELOPMENT COUNCIL OF MANILA PURSUANT TO THE LOCAL GOVERNMENT CODE OF 1991**

WHEREAS, under *Section 455 paragraph (b)(1)(ii) of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991*, the undersigned Mayor of the City of Manila has the power to direct the formulation of the city development plan, with the assistance of the city development council, and upon approval thereof by the Sangguniang Panlungsod, implement the same;

WHEREAS, Section 106 of the Local Government Code provides for the creation of a Local Development Council in every local government unit;

WHEREAS, the Local Development Council shall be tasked to initiate the crafting of a comprehensive multi-sectoral development plan and assist the Sangguniang Panglungsod in setting the direction of economic and social development, and coordinating development efforts within its territorial jurisdiction.

THEREFORE, I, **MARIA SHEILAH "HONEY" H. LACUNA-PANGAN, MD, FPDS**, Mayor of the City of Manila, by virtue of the powers vested in me by the 1987 Philippine Constitution, the Local Government Code, and existing laws, hereby order the organization and composition of the Local Development Council as follows:

Section 1. Organization. The City Development Council of Manila (CDC) is hereby organized and constituted. It shall be composed of the following:

Chairman: **MARIA SHEILAH "HONEY" H. LACUNA-PANGAN, MD, FPDS**  
*Mayor of the City of Manila*

Members:

- All Punong Barangays in the City of Manila;
- Chairman of the Committee on Appropriation of the Sangguniang Panlungsod;
- Six (6) Congressmen of the City of Manila or their representatives; and
- Representatives from the private sector or non-government organization which shall not be less than one-fourth of the members of the fully organized council

Section 2. Duties and Functions. The CDC shall perform the duties and functions provided therefor under Section 109 of the Local Government Code.

Section 3. Meetings. The CDC shall meet at least once every six (6) months or as often as may be necessary upon call by the Chairman.

Section 4. Executive Committee. The CDC shall have an Executive Committee as provided under Section 111 of the Local Government Code. The Executive Committee shall represent the CDC and act on the latter's behalf when it is not in session. The Executive Committee shall be composed of the following:

Chairman: MARIA SHEILAH "HONEY" H. LACUNA-PANGAN, MD, FPDS  
*Mayor of the City of Manila*

Members: - President of the Liga ng mga Barangay;  
- Chairman of the Committee on Appropriations of the Sangguniang Panlungsod; and  
- a representative of non-governmental organizations that are represented in the CDC

Section 5. Powers and Functions of Executive Committee. The Executive Committee shall exercise such powers and functions as stated in Section 111 (b) of the Local Government Code.

Section 6. Secretariat. The Secretariat as provided under Section 113 of the Local Government Code shall provide technical and secretarial support to the CDC and shall be composed of the following:

1. Head - City Planning Development Coordinator III
2. Member - President of the Liga ng mga Barangay
3. Member - City Director of the Department of Interior and Local Government-Manila


Section 7. Role of the Secretariat. The Secretariat shall be responsible for providing technical support, documentation of proceedings, preparation of reports and such other assistance, as may be required by the CDC. The Secretariat may request the assistance of the City Planning Office and the Liga ng mga Barangay for administrative and logistical support.

Section 8. All prior inconsistent orders, issuances, or directives are considered repealed or modified accordingly.


Section 9. This Order consists of only two (2) pages and shall take effect immediately upon issuance.

Section 10. A copy of this Executive Order shall be furnished the Office of the President, Malacañang Palace, pursuant to paragraph (b)(xii), Section 455 of the Local Government Code of 1991.
