EXECUTIVE ORDER NO. 19

**MANILA CITY ROADS, BOULEVARDS, STREETS, AND ALLEYS WHERE THE NO-PARKING-NO-VENDING POLICY WILL BE STRICTLY IMPLEMENTED**

WHEREAS, under *Section 455 paragraph (b)(4)* in relation to *Section 17 of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991*, the undersigned Mayor of the City of Manila has the duty to ensure the delivery of basic services and the provision of adequate facilities to Manilaños;

WHEREAS, Executive Order No. 07-A Series of 2022 created the Task Force Against Road Obstructions (TFARO) to carefully study and identify city roads, boulevards, streets and alleys where the no-parking-no-vending policy will be strictly implemented in order to ease foot and vehicle traffic in the City of Manila and provide safe pedestrian passage to Manilaños;

WHEREAS, the TFARO submitted to the Office of the Mayor a list of priority roads for clearing with supporting displacement strategies for Manilaño vendors;

THEREFORE, I, **MARIA SHEILAH "HONEY" H. LACUNA-PANGAN, M.D, FPDS**, Mayor of the City of Manila, by virtue of the powers vested in me by the 1987 Philippine Constitution, the Local Government Code of 1991, and existing laws, hereby order that there shall be no vending or parking in the following roads:

Section 1. The following roads are hereby declared no-vendors, no-parking zones:

Section 2. The following roads are hereby declared no-vendor zones with allowed one lane parking only:

1. Recto	Asuncion	Juan Luna
2. Kalaw	Roxas Blvd.	Taft Avenue

Section 3. All Mabuhay Lanes declared as such by the Metropolitan Manila Development Authority (MMDA) shall maintain their status as such subject to its regulations.


Section 4. The TFARO, subject to its mandate, shall ensure that the policy laid down in this executive order is carried out strictly and at all times.

Section 5. All prior inconsistent orders, issuances, or directives are considered repealed or modified accordingly.


Section 6. This Order consists of only two (2) pages and shall take effect immediately upon issuance.

Section 7. A copy of this Executive Order shall be furnished the Office of the President, Malacañang Palace, pursuant to paragraph (b)(xii), Section 455 of the Local Government Code of 1991.
