FLYING OF ALL PHILIPPINE FLAGS IN HALF-MAST IN THE CITY OF MANILA AS A SYMBOL OF MOURNING, RESPECT AND SALUTE TO HIS EXCELLENCY, FIDEL V. RAMOS, 12TH PRESIDENT OF REPUBLIC OF THE PHILIPPINES

WHEREAS, on 31 July 2022, it was officially announced that Former President Fidel V. Ramos joined our Creator at the age of 94;

WHEREAS, the City of Manila, together with the whole nation, grieves the loss of a great man, the 12th President of the Republic of the Philippines, His Excellency Fidel V. Ramos, known for his massive economic liberalization under whose term the Philippines was dubbed the "Tiger Cub Economy of Asia" and "Asia's New Darling";

WHEREAS, *Section 23 (a) of Republic Act No. 8491* otherwise known as the *Flag and Heraldic Code of the Philippines* requires that the Philippine flag be flown at half-mast as a sign of mourning on all the buildings and places where it is displayed for ten (10) days following the official announcement of death of a former President;

THEREFORE, I, **MARIA SHEILAH "HONEY" H. LACUNA-PANGAN, MD, FPDS**, Mayor of the City of Manila, by virtue of the powers vested in me by the 1987 Philippine Constitution, the Local Government Code of 1991, and existing laws, hereby decree the following:

Section 1. *Half-Mast Philippine Flag*. All Philippine Flags being flown in the City of Manila shall be on half-mast from 1 August 2022 up to 10 August 2022, to mourn the death of His Excellency Fidel V. Ramos, 12th President of the Republic of the Philippines. Such gesture also expresses the City's respect and salute to a great man.

Section 2. *Coverage*. All buildings in the City of Manila whether public or private shall fly their Philippine Flags at half-mast on the dates stated in Section 1 hereof to show respect to, and mourn the death of His Excellency Fidel V. Ramos, 12th President of the Republic of the Philippines.

Section 3. This Order consists of only two (2) pages and shall take effect immediately upon issuance.

Section 4. A copy of this Executive Order shall be furnished the Office of the President, Malacañang Palace, pursuant to paragraph (b)(xii), Section 455, the Local Government Code of 1991.
