EXECUTIVE ORDER NO. 32 Series of 2022

ADOPTION OF A RELOCATION AND DISPLACEMENT PLAN IN RELATION TO EXECUTIVE ORDER NO. 15 SERIES OF 2022, AMENDING SECTIONS 2 AND 3 THEREOF

WHEREAS, under Section 455 paragraph (b)(4) in relation to Section 17 of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991, the undersigned Mayor of the City of Manila has the duty to ensure the delivery of basic services and the provision of adequate facilities to Manileños;

WHEREAS, on 26 July 2022, Executive Order No. 15 Series of 2022 took effect designating several roads recommended by the Task Force Against Road Obstructions (TFARO) as no-parking-no-vending zones;

WHEREAS, vehicle and foot traffic being fluid situations and considering the current changes brought about by the approaching opening of face-to-face classes inevitably resulting to a considerable increase in commercial activities in the City of Manila, the TFARO submitted to the Office of the Mayor a practicable relocation and displacement plan for the city's road users and for the benefit of every Manileño;

THEREFORE, I, MARIA SHEILAH "HONEY" H. LACUNA-PANGAN, M.D, FPDS, Mayor of the City of Manila, by virtue of the powers vested in me by the 1987 Philippine Constitution, the Local Government Code of 1991, and existing laws, hereby adopt the recommendation of the Task Force Against Road Obstructions on the following relocation and displacement plan thereby amending Sections 2 and 3 of Executive Order No. 15, Series of 2022 as follows:

Section 1. The following roads are hereby declared no-vendor, no-parking zones with relocation areas for displaced vendors:

Section 5. All Mabuhay Lanes declared as such by the Metropolitan Manila Development Authority (MMDA) shall maintain their status as such subject to its regulations.

Section 6. The TFARO, subject to its mandate, shall ensure that the policy laid down in this executive order is carried out strictly and at all times.

Section 7. All prior inconsistent orders, issuances, or directives are considered repealed or modified accordingly.

Section 8. This Order consists of only five (5) pages and shall take effect immediately upon issuance.

Section 9. A copy of this Executive Order shall be furnished the Office of the President, Malacañang Palace, and the Manila Police District pursuant to paragraph (b)(xii), Section 455 of the Local Government Code of 1991.
