**RECONSTITUTION OF THE COMMITTEE ON AWARDS FOR
DISPOSAL OF UNSERVICEABLE PROPERTIES**

WHEREAS, under *Section 455 paragraph (b)(3)(vii) of Republic Act (R.A.) No. 7160*, otherwise known as the *Local Government Code of 1991*, the undersigned Mayor of the City of Manila has the duty to provide efficient and effective property and supply management in the city;

WHEREAS, *Title V of the Commission on Audit Circular No. 92-386* otherwise known as *Rules and Regulations on Supply and Property Management in the Local Government* provides for the procedure to be adopted in disposing unserviceable supplies or properties/equipment owned by the city;

THEREFORE, I, **MARIA SHEILAH "HONEY" H. LACUNA-PANGAN, MD, FPDS**, Mayor of the City of Manila, by virtue of the powers vested in me by the 1987 Philippine Constitution, the Local Government Code of 1991, and existing laws, hereby order the reconstitution of the Committee on Awards for Disposal of Unserviceable Properties as follows:

Section 1. *Composition*. The Committee on Awards for Disposal of Unserviceable Properties shall be composed of the following:

- Chairperson : Mayor of the City of Manila
(Assisted by the Secretary to the Mayor)
- Vice-Chairperson : Chairman, Bids and Awards Committee
- Members : - Officer-In-Charge, City General Services Office
- Officer-In-Charge, Department of Assessment
- Representative, Concerned Department
- Representative, Commission on Audit


Section 2. *Duties and Functions*. The Committee shall exercise such duties and functions based on the provisions of *Title V of the Commission on Audit Circular No. 92-386* insofar as applicable and is directed to convene immediately to determine the necessity of disposing unserviceable supplies and equipment of the City of Manila.


Section 3. All prior inconsistent orders, issuances, or directives are considered repealed or modified accordingly.

Section 4. This Order consists of only two (2) pages and shall take effect immediately

Section 5. A copy of this Executive Order shall be furnished the Office of the President, Malacañang Palace, pursuant to paragraph (b)(xii), Section 455 of the Local Government Code of 1991.
