## ORDINANCE NO. 8942

**AN ORDINANCE** FURTHERMORE AMENDING SECTION 2.A OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF ORO-B, ZOBEL ROXAS, SAN ANDRES, STA. ANA, TEJERON TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (OZSSAT TODA) INC., AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SECTION 1.** Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended by including therein the loading and unloading areas of Oro-B, Zobel Roxas, San Andres, Sta. Ana, Tejeron Tricycle Operators and Drivers Association (OZSSAT TODA) Inc., to read as follows:

**“ORO-B, ZOBEL ROXAS, SAN ANDRES, STA. ANA, TEJERON TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (OZSSAT TODA) INC.**

**Loading and Unloading Areas**

- a. Zobel Roxas in front of Barangay Hall 770 south bound lane Makati boundary
- b. Zobel Roxas St. corner Onyx St.
- c. Pasig Line St. corner Augusto Francisco St., Arellano St., Eloriaga St.
- d. Pasig Line St., Pedro Gil St.”

**SEC. 2.** Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended by including therein the Route Measure Capacity and authorized route line of Oro-B, Zobel Roxas, San Andres, Sta. Ana, Tejeron Tricycle Operators and Drivers Association (OZSSAT TODA) Inc. to read as follows:

**“ASSOCIATION**

**ROUTE**

The authorized additional route lines of operation shall begin in the area of Pasig Line St. – Augusto Francisco St. – Tejeron St.”

**SEC. 3. Separability Clause.** – If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.

**SEC. 4. Repealing Clause.** – All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

**SEC. 5. Effectivity Clause.** – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on March 16, 2023.


