Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Section 2.A (Pedicab Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of Baseco Padyak Operators and Drivers Association (BASECO PODA), to read as follows:

Loading and Unloading Areas

- 1. Block 17A Old Site H.J. Atienza Elementary School
- 2. Block 17B GK Healing Source
- 3. Block 9 Old Site
- 4. Block 1 Habitat Baseco Public Market
- 5. Block 1 New Site Evacuation Center
- 6. Benigno Aquino Health Center
- 7. Block 1 Gasangan
- 8. Block 15B Gasangan"

SEC. 2. The Route Measure Capacity and authorized route line of Baseco Padyak Operators and Drivers Association (BASECO PODA) are as follows;

ROUTE

The authorized additional route lines of operation shall be within the jurisdiction of Barangay 649 (Baseco)"
