WHEREAS, this Resolution is in pursuance with the issuance of the Department of the Interior and Local Government (DILG) Memorandum Circular No. 97-306 dated November 25, 1997, relative to the establishment and maintenance of friendly ties, peace and unity and to participate in significant activities geared towards the enhancement and to enliven the cultural, economic and livelihood programs, mutually beneficial among the local government units;

WHEREAS, the Municipality of San Isidro, Province of Leyte, furnished the Honorable Maria Sheilah "Honey" H. Lacuna-Pangan, MD, FPDS, a copy of their Municipal Resolution No. 2023-071, duly adopted by its Sangguniang Bayan on January 17, 2023, captioned: "A RESOLUTION SIGNIFYING THE INTEREST OF THE MUNICIPALITY OF SAN ISIDRO, LEYTE TO ESTABLISH A SISTERHOOD/TWINNING NEGOTIATION AND RELATIONSHIP AGREEMENT WITH THE CITY OF MANILA";

WHEREAS, this Resolution is intended to uplift the spirit of mutual friendship and goodwill to strengthen economic gains, creativity, skills development that would help pave their vision of progress, to encourage the constituents to be productive and sustainable in various development programs, in the areas of trade and investment, human development, health, culture, education and tourism;


WHEREAS, in behalf of the people of San Isidro, Leyte, led by Honorable Mayor, Remedio B. Veloso, and duly concurred by the Honorable Members of the Sangguniang Bayan of said municipality, sought our favorable support of consenting to a Twinning Relationship which is hoped to establish and maintain a lasting relationship where projects and exchange of mutual interest is geared to strengthen economic and cultural gains: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to authorize, as it hereby authorizes the establishment of a Twinning Relationship between the City of Manila and the Municipality of San Isidro, Province of Leyte; and be it FURTHER

RESOLVED, that the City Mayor of Manila, Honorable Maria Sheilah "Honey" H. Lacuna-Pangan, MD, FPDS, be authorized to execute and sign said agreement; and be it FINALLY

RESOLVED, that a copy of this Resolution be furnished the Municipality of San Isidro, Province of Leyte.
