WHEREAS, the SAMAHAN NG DATING BARANGAY OFFICIAL SA PAGSULONG NG MAYNILA INC., with office address at 1213 Makata Street, Sta. Cruz, Manila, a duly registered organization with the Securities and Exchange Commission (SEC), is seeking accreditation as registered Non-Governmental Organization (NGO);

WHEREAS, SAMAHAN NG DATING BARANGAY OFFICIAL SA PAGSULONG NG MAYNILA INC., aims to contribute in the upliftment and development of the quality of life, not only of the members, but also of the less fortunate members of the society, as well as launching various humanitarian and livelihood programs that are designed to promote self-reliance and economic independence;

WHEREAS, the Association's purposes are as follows:

- To initiate and promote a healthy and harmonious relationship among members by developing the civic, spiritual, social and cultural awareness and consciousness of its members;
- 2. To uplift the living conditions of members by assisting them in the establishments of livelihood facilities, services and enterprises;
- 3. To provide medical assistance, scholarship grant to deserving members and their family;
- To acquire loans, from not more than 19 lenders, including its member or other financial accommodations from the government and private lending institutions in order to figance productive and livelihood enterprises;
- 5. To seek assistance and guidance of government and private institutions necessary to achieve the full realization of the association's objectives;
- To receive and accept donations, grants and bequests, from other government agencies and private entities for the benefit of the corporation; and
- 7. To perform other activities as may be necessary, convenient and appropriate for the accomplishment of the foregoing purposes. Provided the same shall not engage in partisan political activities.

WHEREAS, the same organization submitted the accomplished requisites and supporting documents for purposes of accreditation;

WHEREAS, after careful study and perusal of all the requirements submitted, it was established that it has all the qualifications to be accredited as a Non-Governmental Organization of Manila: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to grant, as it hereby grants the accreditation of Samahan ng Dating Barangay Official sa Pagsulong ng Maynila Inc., to become an accredited Non-Governmental Organization of the City of Manila; and be it FURTHER

RESOLVED, that a corresponding Certificate of Accreditation be attached hereto and be issued to the said association; and be it FINALLY

RESOLVED, that copies of this Resolution be furnished the Department of the Interior and Local Government (DILG) and the NGO concerned.
