**RESOLUTION** GRANTING THE RENEWAL FOR ACCREDITATION OF ENVIRONMENTALLY-SUSTAINABLE TRICYCLES IN MANILA ALLIANCE TRANSPORT SERVICE COOPERATIVE (ESTIMA-TSC), TO BECOME AN ACCREDITED COOPERATIVE OF THE CITY OF MANILA

WHEREAS, the ENVIRONMENTALLY-SUSTAINABLE TRICYCLES IN MANILA ALLIANCE TRANSPORT SERVICE COOPERATIVE (ESTIMA-TSC), with office address at 2237 Kusang Loob Street, Barangay 312, Sta. Cruz, Manila, a duly registered organization with the Cooperative Development Authority (CDA) is seeking accreditation as registered Cooperative;

WHEREAS, ESTIMA-TSC, aims to contribute to uplift and develop the quality of life, not only the members, but also to the less fortunate members of the society, as well as launching various humanitarian and livelihood programs that are designed to promote self-reliance and economic independence;

WHEREAS, the Association's purposes are as follows:

1. Provide safe, efficient, environment – friendly, climate-resilient, reliable and people-oriented public transport services, more specifically tricycles for hire, primarily to members and the commuting public;
2. Engage in allied services or businesses such as:
  - a. Importation, distribution and marketing of automotive supplies in accordance with existing laws;
  - b. Operation of fuels and other forms of energy stations and vehicle service centers;
  - c. Importation, distribution and marketing of other consumer products; and
  - d. Marketing of Insurance policies related to public transportation service;
3. Promoting and advancing the economic and social status of the members;
4. Coordinating and facilitating the activities of cooperatives;
5. Advocating for the cause of the cooperative movements;
6. Ensuring the viability and competitiveness of cooperatives through the utilization of new technologies and best practices; and
7. Encouraging and promoting self-help or self-employment as an engine for economic growth and poverty alleviation.

WHEREAS, the same organization submitted the accomplished requisites and supporting documents for purposes of accreditation;

WHEREAS, after careful study and perusal of all the requirements submitted, it was established that it has all the qualifications to be accredited as a Cooperative of Manila: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to grant, as it hereby grants the renewal for accreditation of Environmentally-Sustainable Tricycles in Manila Alliance Transport Service Cooperative (ESTIMA-TSC), to become an accredited Cooperative of the City of Manila; and be it FURTHER

RESOLVED, that a corresponding Certificate of Accreditation be attached hereto and be issued to the said association; and be it FINALLY

RESOLVED, that copies of this Resolution be furnished the Department of the Interior and Local Government (DILG) and the Cooperative concerned.
