AN ORDINANCE GRANTING EXEMPTION FROM PAYMENT OF AMUSEMENT TAX FOR THE STAGING OF SEASON 98 VOLLEYBALL TOURNAMENT BY THE NATIONAL COLLEGIATE ATHLETIC ASSOCIATION AT THE SAN ANDRES SPORTS COMPLEX, MALATE, MANILA FOR THE PERIOD FEBRUARY 21 TO MARCH 23, 2023 AS SOUGHT BY FR. VIRGILIO M. PAREDES, JR., OAR

EXPLANATORY NOTE

The National Collegiate Athletic Association (NCAA) is the oldest athletic association in the country, founded in 1924. The Board and the Committee are composed of representatives of the eight member schools. The NCAA has eleven (11) sports that the association sponsors, divided into two categories: the junior division for high school students and the senior division for collegiate students.

With the 98th season of the NCAA being hosted by the Emilio Aguinaldo College, in the City of Manila, comes the responsibility of bearing the fees and taxes to be paid to ensure the successful implementation of the competition and provide a venue for camaraderie and sportsmanship among Filipino athletes of all ages.

Through a letter dated 21 March 2023 by Fr. Virgilio M. Paredes Jr., OAR, Chairman of the 98th Season of the NCAA for the Volleyball tournament, the Association is requesting for the exemption of payment of amusement tax for the usage of the San Andres Sports Complex, located at Malate, Manila, commonly paid to the City Treasurer's Office, subject to the approval of the City Council of Manila.

In which, the City Legal Office expressed in a 11 May 2023 letter of no objection to the tax exemption being applied for by the National Collegiate Athletic Association (NCAA) for the period of February 21 to March 23, 2023.

In the spirit of supporting such activities, the city shall continuously seek ways to be a venue for activities that enrich the physical and psychological capacity of the students of the city, thus, shall therefore pass an ordinance granting the request of the same.

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Exemption from payment of amusement tax for the staging of National Collegiate Athletic Association Season 98 Volleyball Tournament as sought by Fr. Virgilio M. Paredes, Jr., OAR, using San Andres Sports Complex, Malate, Manila for the period February 21 to March 23, 2023, is hereby granted and authorized.

SEC. 2. Effectivity Clause. - This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila May 16, 2023.
