## **ORDINANCE NO. 8962**

AN ORDINANCE FURTHERMORE AMENDING SECTION 2.A OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF MABUHAY ESTRADA STA. ANA TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (MESA TODA) AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of MABUHAY ESTRADA STA. ANA TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (MESA TODA), to read as follows:

# "MABUHAY ESTRADA STA. ANA TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (MESA TODA)

## **Loading and Unloading Areas**

- a. Mabuhay Street corner Pasig Line Street
- b. Sagrada Familia Street corner Araullo Street
- c. Sagrada Familia Street corner Arellano Street
- d. Sagrada Familia Street corner Eloriaga Street
- e. Sagrada Familia Street corner Oro B Street
- f. Sagrada Familia Street corner Tenorio Street
- g. Sagrada Familia Street corner Chromium Street
- h. Sagrada Familia Street corner Radium Street
- i. Agosto Francisco Street corner Arellano Street, Eloriaga Street
- j. Pasig Line Street corner Pedro Gil Street"

SEC. 2. Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of MABUHAY ESTRADA STA. ANA TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (MESA TODA), to read as follows:

#### "ASSOCIATION

R.M.C.

MABUHAY ESTRADA STA. ANA TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (MESA TODA)

220 Units

#### ROUTE

The authorized route lines of operation shall begin in the area of Pasig Line Street – Agosto Francisco Street – Tejeron Street – Onyx Street."

- SEC. 3. Separability Clause. If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.
- SEC. 4. Repealing Clause. All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.
  - SEC. 5. Effectivity Clause. This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on May 23, 2023.
