

ORDINANCE NO. 7866

AN ORDINANCE PENALIZING THE DISPOSAL OF GARBAGE, DEBRIS AND OTHER WASTE MATERIALS IN RIVERS, CREEKS, CANALS AND WATERWAYS; PROVIDING PENALTIES FOR VIOLATION THEREOF; ALLOCATING TO THE BARANGAYS 20% OF THE FINE COLLECTED THEREFROM AND FOR OTHER PURPOSES.

Be it ordained by the City Council of Manila, THAT

SECTION 1. In line with the clean-up drive of the government, the City of Manila hereby adopts the policy of strictly prohibiting the disposal of garbage, debris and other waste materials in rivers, creeks, canals and waterways within its territorial jurisdiction;

SEC. 2. Any individual, association, partnership or corporation is hereby strictly prohibited to dispose garbage, debris of whatever form, harmful substances and other unwanted materials, in rivers, creeks, canals and waterways that are within the territory of the City.

SEC. 3. The Office of the Mayor is authorized to organize a task force to administer and supervise the proper implementation of the City's clean-up drive in coordination with the barangays. Twenty percent (20%) of the fine to be imposed upon any individual, association, partnership or corporation who are caught and found violating the provisions of this Ordinance, shall be allocated to the barangay where the violation was committed to form part of the barangay fund.

SEC. 4. Any violation of this Ordinance shall be punishable by a fine of THREE THOUSAND PESOS (P3,000.00) and/or imprisonment of thirty (30) days or both upon the discretion of the court.

If the violation is committed by a juridical person, the manager, managing partner or director or person in charge of management or operation shall be held liable therefor.


SEC. 5. All ordinances or portions thereof which are inconsistent with the provisions of this Ordinance are hereby deemed modified, amended or repealed accordingly.


SEC. 6. This Ordinance shall take effect immediately upon its approval.




