

ORDINANCE NO. 7986

AN ORDINANCE PROHIBITING THE TOWING OF PARKED MOTOR VEHICLES ON ANY STREET, ROAD OR THOROUGHFARE NOT DECLARED AS NO PARKING OR TOW-AWAY ZONE UNDER EXISTING ORDINANCES.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. It shall hereby be unlawful for any person to tow vehicles parked on any street, road or thoroughfare not declared as no parking or tow-away zone in the City of Manila, under existing Ordinances.

SEC. 2. Penalty Clause - Any person found infringing or violating this Ordinance shall be punished by a fine of Five Thousand Pesos (₱ 5,000.00) and/or one year imprisonment at the discretion of the court.


SEC. 3. Repealing Clause - Any Ordinance, rule and regulation in conflict and inconsistent herewith in part or in whole, is hereby modified or repealed.


SEC. 4. Effectivity Clause. - This Ordinance shall take effect upon approval.


