ORDINANCE NO. 8972

AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 2, FOR THE VARIOUS PRIORITY PROJECTS OF THE CITY OF MANILA IN THE TOTAL AMOUNT OF THIRTY-THREE MILLION SIX HUNDRED FORTY THOUSAND PESOS (Php. 33,640,000.00) AND FOR OTHER PURPOSES.

EXPLANATORY NOTE

Section 16 of Republic Act No. 7160 or the Local Government Code (LGC) of 1991 provides that local government unit (LGU) shall exercise the powers that are necessary, appropriate, or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare. It shall ensure and support, among other things the enhancement of the right of the people to a balanced ecology and the preservation of the comfort and convenience of its inhabitants.

Further, Section 17 of the LGC mandates LGUs to exercise such powers and discharge such functions and responsibilities for the efficient and effective provisions of basic services and facilities which includes, among others, services and facilities related to general hygiene and sanitation, drainage and sewerage systems and other infrastructure facilities to service the needs of the residents.

To fund urgent expenses and projects of the City, a supplemental budget may be enacted when supported by funds actually available as certified by the local treasurer or by new revenue sources (Section 321 of R.A. No. 7160).

The City Treasurer and the City Accountant has issued the Certificate of Availability of Funds as supporting document to the promulgation of this Supplemental Budget.

The City Council likewise approved Resolution No. 2, Series of 2023 of the Executive Committee of the City Development Council (CDC), entitled "A RESOLUTION APPROVING THE AMENDMENT OF THE ANNUAL INVESTMENT PROGRAM AND ISSUANCE OF A SUPPLEMENTAL INVESTMENT PROGRAM FOR FY 2023 FOR THE VARIOUS PRIORITY IMPROVEMENT PROJECTS OF THE CITY OF MANILA IN THE TOTAL AMOUNT OF THIRTY-THREE MILLION PESOS (Php. 33,000,000.00)".

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Appropriations. - The FY 2023 Supplemental Budget of the City of Manila in the total amount of Thirty-Three Million Six Hundred Forty Thousand Pesos (PhP. 33,640,000.00), is hereby appropriated to fund the following projects of the City of Manila, to wit;
