WHEREAS, the City of Manila, under the leadership of Hon. Maria Sheilah "Honey" H. Lacuna-Pangan, MD, FPDS, aims to establish partnerships with other local government units in the century to foster cooperation and collaboration for mutual benefit and progress;

WHEREAS, the Municipality of Dumalag, Province of Capiz, through Mayor Maria Conception T. Castro, has expressed its interest in establishing a twinning agreement with the City of Manila to enhance economic, cultural, educational, and social ties between the two LGUs last February 23, 2023 through official communication;

WHEREAS, the proposed twinning agreement includes provisions for the exchange of best practices, experiences, and expertise in various fields such as tourism initiatives, economic development and investment opportunities, and to learn more specially on other dimensions of Disaster Risk Reduction and Management (DRRM) and Engineering;

WHEREAS, the proposed twinning agreement also includes provisions for the conduct of joint activities and projects, such as cultural and sports events, trade fairs, medical missions, and capacity-building programs, to promote people-to-people exchanges and learning opportunities;



RESOLVED, by the City Council of Manila to authorize, as it hereby authorizes the establishment of a twinning agreement between the City of Manila and the Municipality of Dumalag, Province of Capiz; and be it FURTHER

RESOLVED, that the City Mayor of Manila, Honorable Maria Sheilah "Honey" H. Lacuna-Pangan, MD, FPDS, be authorized to execute and sign said agreement; and be it FURTHERMORE
