WHEREAS, the Municipality of Dupax Del Norte, Province of Nueva Vizcaya, furnished this body a certified copy of their Municipal Resolution No. 154, Series of 2022, dated August 22, 2022, expressing their earnest desire to forge a sisterhood relationship with the City of Manila;

WHEREAS, the proposed twinning agreement includes provisions for the exchange of ideas and experiences in various fields, such as, science and technology, tourism, culture and arts, urban planning and development, commerce/trade and industry, education and health, sports development, and social services, among others;

WHEREAS, the proposed twinning agreement also includes provisions for the conduct of joint activities and projects, such as cultural and sports events, trade fairs, medical missions, and capacity-building programs, to promote people-to-people exchanges and learning opportunities;



RESOLVED, by the City Council of Manila to authorize, as it hereby authorizes the establishment of a twinning agreement between the City of Manila and the Municipality of Dupax Del Norte, Province of Nueva Vizcaya; and be it FURTHER

RESOLVED, that the City Mayor of Manila, Honorable Mayor Maria Sheilah "Honey" H. Lacuna-Pangan, MD, FPDS, be authorized to execute and sign said agreement; and be it FURTHERMORE
