
WHEREAS, Administrative Order No. 2020-0024 centers on the matter of Primary Care Policy Framework and Sectoral Strategies that include, among others, the capacity enhancement of primary care workers including Barangay Health Workers as designated Health Promotion Officers, while Administrative Order No. 2021-0063 focuses on Health Promotion Framework Strategy that serves as key basis for all health promotion policies, programs and activities at the national, regional and local levels including the City of Manila;

WHEREAS, both issuances seek to complement the delivery of primary health care services on a community-based level through the immersive participation of our beloved City to the advantage of the Manileños;

WHEREAS, such intent of the City Government is seen with merit, for which expediency urges favorable action: NOW, THEREFORE, be it
