WHEREAS, this Sanggunian authorized the establishment of a twinning agreement with the Municipality of Leganes, Province of Iloilo last January 28, 2021 by virtue of Resolution No. 28, entitled: "RESOLUTION ESTABLISHING A TWINNING CITY-MUNICIPAL ALLIANCE BETWEEN THE CITY OF MANILA AND MUNICIPALITY OF LEGANES, PROVINCE OF ILOILO AND AUTHORIZING HIS HONOR, MAYOR FRANCISCO "ISKO MORENO" DOMAGOSO TO ENTER INTO AN APPROPRIATE AGREEMENT";

WHEREAS, considering the prevailing emergency health condition around the period the measure was passed, the same was not consummated nor was it implemented during that time;



RESOLVED, by the City Council of Manila to authorize, as it hereby authorizes to proceed with the establishment of the twinning relationship between the City of Manila and the Municipality of Leganes, Province of Iloilo, by virtue of Resolution No. 28, Series of 2021, adopted on January 28, 2021; and be it FURTHER

RESOLVED, that the City Mayor of Manila, Honorable Maria Sheilah "Honey" H. Lacuna-Pangan, MD, FPDS, be authorized to execute and sign said agreement; and be it FINALLY
