
WHEREAS, on May 4, 2023 at around 3:30 P.M., a fire broke out and razed a portion of 2313 Jacobo St., Sta. Ana, Manila, within the territorial jurisdiction of Barangay 753, Zone 81, District V, rendering more or less, twenty-five (25) families or one hundred one (101) individuals affected;

WHEREAS, the Sangguniang Barangay, through Punong Barangay Reynaldo D. Habayhabay, requested the City Council that their barangay be declared a calamity area so that their calamity fund be released to alleviate the needs of the victims: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to declare, as it hereby declares that portion of Barangay 753, Zone 81, in the Fifth District, which was razed by fire on May 4, 2023, A CALAMITY AREA; and be it FURTHER

RESOLVED, that a copy of this Resolution be furnished the above-mentioned barangay for legislative support purposes to facilitate the immediate release of barangay calamity fund thereof.
