
WHEREAS, on May 5, 2023 at around 11:03 A.M., a fire broke out and razed a portion of Tejeron corner Liwayway Sts., Sta. Ana, Manila, within the territorial jurisdiction of Barangay 783, Zone 85, District V, rendering more or less, forty-one (41) families or one hundred forty-nine (149) individuals affected;

WHEREAS, the Sangguniang Barangay, through Punong Barangay Gloria Hoffman, requested the City Council that their barangay be declared a calamity area so that their calamity fund be released to alleviate the needs of the victims: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to declare, as it hereby declares that portion of Barangay 783, Zone 85, in the Fifth District, which was razed by fire on May 5, 2023, A CALAMITY AREA; and be it FURTHER

RESOLVED, that a copy of this Resolution be furnished the above-mentioned barangay for legislative support purposes to facilitate the immediate release of barangay calamity fund thereof.
