WHEREAS, the City of Manila, under the leadership of Hon. Maria Sheilah "Honey" H. Lacuna-Pangan, MD, FPDS, aims to establish partnerships with other local government units of the country to foster cooperation and collaboration for mutual benefit and progress;

WHEREAS, the Municipality of Bongabon, Province of Nueva Ecija, furnished this body a certified copy of their Municipal Resolution No. 47-S-2023, Series of 2023, dated March 13, 2023, signifying interest to establish a sisterhood relationship with the City Government of Manila;

WHEREAS, the proposed twinning agreement includes provisions for the exchange ideas and experiences in various fields such as science and technology, tourism, culture and arts, urban planning and development, commerce/trade and industry, education and health, sports development, and social service, among others;

WHEREAS, the proposed twinning agreement also includes provisions for the conduct of joint activities and projects, such as cultural and sports events, trade fairs, medical missions, and capacity-building programs, to promote people-to-people exchanges and learning opportunities;

WHEREAS, the proposed twinning agreement is deemed to be beneficial to the Municipality of Bongabon and the City of Manila, and will surely serve its purpose: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to authorize, as it hereby authorizes the establishment of a twinning agreement between the City of Manila and the Municipality of Bongabon, Province of Nueva Ecija; and be it FURTHER

RESOLVED, that the City Mayor of Manila, Honorable Maria Sheilah "Honey" H. Lacuna-Pangan, MD, FPDS, be authorized to execute and sign said agreement; and be it FINALLY

RESOLVED, that copies of this Resolution be furnished the Office of the Municipal Mayor, Honorable Ricardo I. Padilla and the Sangguniang Bayan of Bongabon, Province of Nueva Ecija.
