RESOLUTION ENJOINING ALL BARANGAYS, SCHOOLS, OFFICES, AGENCIES, GOVERNMENT AND NON-GOVERNMENTAL INSTITUTIONS, BUSINESS ESTABLISHMENTS, AND PRIVATE OR RESIDENTIAL HOMES AND BUILDINGS IN THE CITY OF MANILA TO DISPLAY THE PHILIPPINE FLAG TO COMMEMORATE THE NATIONAL FLAG DAY FROM MAY 28 TO JUNE 12, 2023

WHEREAS, on March 6, 1965, Presidential Proclamation No. 374 was issued declaring May 28 as National Flag Day to commemorate the date the national emblem was first publicly displayed after the Philippine Revolutionary Army;

WHEREAS, on May 23, 1994, Executive Order No. 179 was issued extending the period of celebrating the National Flag Day from May 28 to June 12 and the same was incorporated under Section 26 of Republic Act No. 8491 known as the "Flag and Heraldic Code of the Philippines", wherein all offices, agencies and instrumentalities of government, business establishments, institutions of learning and private homes are enjoined display the flag during the period from May 28 to June 12 of each year;


WHEREAS, on May 10, 2023, the City Government of Manila through the Department of Tourism, Culture and Arts issued a correspondence requesting the display of the Philippine Flag in all offices in commemoration of National Flag Day from May 28 to June 12, 2023 as prescribed by law;

WHEREAS, there is a need for the City Government of Manila to remind and inculcate into the minds and hearts of the Filipino people the reverence and respect which must be accorded to the Philippine Flag, the anthem, and other national symbols which embody the national ideals and traditions and which expresses the principles of sovereignty and national solidarity: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to enjoin, as it hereby enjoins all barangays, schools, offices, agencies, government and nongovernmental institutions, business establishments, and private or residential homes and buildings in the City of Manila to display the Philippine Flag to commemorate the National Flag Day from May 28 to June 12, 2023; and be it FURTHER

RESOLVED, that copies of this Resolution be furnished the Manila Barangay Bureau and to all concerned agencies for implementation and appropriate action.
