RESOLUTION TO REGAIN AND MAINTAIN CLEANLINESS, SAFETY AND ENVIRONMENTAL-FRIENDLY COMMUNITY FOR WHICH THE BARANGAY SHALL BE UPFRONT AND RESPONSIBLE IN PROMOTING PUBLIC AWARENESS AND IMPLEMENTATION OF A COMPREHENSIVE CLEAN-UP DRIVE IN COORDINATION WITH THE DEPARTMENT OF PUBLIC SERVICES FOR CLEAN-UP OPERATIONS IN THE DISPOSAL OF BANTINGS, TARPAULINS, GARBAGE AND OTHER WASTE MATERIALS USED AFTER ANY EVENT HELD INCLUDING BUT NOT LIMITED TO FIESTA, WAKES, BIRTHDAYS, PRODUCT ENDORSEMENT AND FOR ANY OTHER OCCASIONS CELEBRATED IN PUBLIC AREAS WITHIN EVERY BARANGAY IN THE CITY OF MANILA
