WHEREAS, on May 24, 2023, the City Council of Manila was in receipt of a letter from Atty. Marlon M. Lacson, Secretary to the Mayor, requesting for adoption of a resolution granting authority to the Local Chief Executive to enter into a Memorandum of Agreement (MOA) with the Department of Labor and Employment (DOLE), for the implementation of Government Internship Program (GIP);

WHEREAS, the letter-request, together with the proposed Memorandum of Agreement was referred to the City Council for appropriate action;


WHEREAS, said program aims to provide the beneficiaries, particularly the poor/indigent, the opportunity to demonstrate their talents and skills in the field of public service with the ultimate objective of attracting the best and brightest who wants to pursue a career in the government service, particularly in the fields related to labor and employment;

WHEREAS, the draft Memorandum of Agreement has reached the open session of the policy-making body and after a brief discussion reached a consensus to approve the request: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to authorize, as it hereby authorizes the Honorable City Mayor, Maria Sheilah "Honey" H. Lacuna-Pangan, MD, FPDS, representing the City Government of Manila, to enter into a Memorandum of Agreement with the Department of Labor and Employment, for the implementation of Government Internship Program; and be it FURTHER
