LIM, CHIEF PROSECUTOR, FOR ACHIEVING A 5.0 FINAL WEIGHTED SCORE EQUIVALENT TO AN ADJECTIVAL RATING OF "OUTSTANDING" AWARDED BY THE OFFICE OF THE SECRETARY OF JUSTICE PROSECUTION STAFF OF THE DEPARTMENT OF JUSTICE FOR THE YEAR 2022
