AN ORDINANCE FURTHERMORE AMENDING SECTION 2.a OF ORDINANCE, NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREA OF EL PUEBLO CONDOMINIUM TRICYCLE OPERATORS AND DRIVERS ASSOCIATION AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, is hereby furthermore amended, by including therein the loading and unloading area of El Pueblo Condominium Tricycle Operators and Drivers Association, (EPCTODA), to read as follows:

"EL PUEBLO CONDOMINIUM TRICYCLE OPERATORS AND DRIVERS ASSOCIATION, (EPCTODA)

Loading and Unloading Area

- a. Anonas Street in Barangay 630, Zone 63, Sta. Mesa, Manila near El Pueblo Condominium"
- **SEC. 2.** Section 2 of Ordinance No. 7871, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of El Pueblo Condominium Tricycle Operators and Drivers Association, to read as follows:

"ASSOCIATION

R.M.C.

El Pueblo Condominium Tricycle Operators and Drivers Association (EPCTODA)

50 Units

ROUTE

The authorized route line of operation shall begin in the area of Anonas Street near El Pueblo Condominium – Teresa Street – PNR Station – Pureza LRT Station – Jasmin Street – Nagtahan Boulevard – Stop and Shop and vice versa."

- SEC. 3. Repealing Clause. All other local laws, decrees, orders, issuances, rules and regulations, which are inconsistent with the provisions of this Ordinance are hereby repealed, amended or modified accordingly.
- **SEC. 4. Effectivity Clause.** This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on November 5, 2015.
