AN ORDINANCE FURTHERMORE AMENDING SECTION 2.A OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF PANDACAN PETER PAUL TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (PAPETODA), INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY


EXPLANATORY NOTE

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of Pandacan Peter Paul Tricycle Operators And Drivers Association (PAPETODA), Inc., to read as follows:

“PANDACAN PETER PAUL TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (PAPETODA), INC.

Loading and Unloading Areas

1. Petron Terminal – Jesus Street cor. Jesus Extension
2. Industria Terminal – Industria Street cor. Jesus Street”

SEC. 2. Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of Pandacan Peter Paul Tricycle Operators And Drivers Association (PAPETODA), Inc., to read as follows:

ROUTE


The authorized route lines of operation shall begin in the area of Petron – Peter Paul – Narciso St. – Industria St. – Labores St. – Teodoro San Luis St. – Pandacan St. – Guanzon St. – vice versa – Robinson Otis (drop only).”

SEC. 3. Effectivity Clause. – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on April 20, 2023.


