ORDINANCE NO. 8960

AN ORDINANCE WITHDRAWING FROM PUBLIC USE THAT PARCEL OF LAND KNOWN AS CALLEJON PACADUA LOCATED ALONG TOMAS MAPUA STREET (FORMERLY MISERICORDIA STREET) WITH A LAND AREA OF NINETY SEVEN SQUARE METERS (97.00 SQ. M.) TO BE USED FOR THE CONSTRUCTION OF A MULTI-PURPOSE HALL OF BARANGAY 301, ZONE 29, DISTRICT III, BINONDO, CITY OF MANILA

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. That Parcel of Land known as Callejon Pacadua located along Tomas Mapua Street (formerly Misericordia Street) with a land area of Ninety Seven Square Meters (97.00 Sq. M.) to be used for the construction of a Multi-Purpose Hall of Barangay 301, Zone 29, District III, Binondo, City Of Manila, is hereby authorized to be withdrawn from public use.

SEC. 2. Effectivity Clause. – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on May 16, 2023.
