AN ORDINANCE EXEMPTING FROM THE PAYMENT OF TRANSFER TAXES AND OTHER INCIDENTAL EXPENSES RELATIVE TO THE TRANSFER OF TITLE OF THAT PATRIMONIAL PROPERTY COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 51486, IN THE REGISTRY OF DEEDS FOR THE CITY OF MANILA, SITUATED AT ARROCEROS COMPOUND, TO BE TRANSFERRED TO RIVERPARK CENTRAL CORPORATION, PURSUANT TO THE AMENDED JOINT VENTURE AGREEMENT BETWEEN THE CITY OF MANILA AND JBROS CONSTRUCTION CORPORATION, DATED 23 MAY 2023

EXPLANATORY NOTE

The City of Manila and JBros Construction Corporation entered into a Joint Venture Agreement (JVA) on 16 June 2017, for the redevelopment of the 10,134 Square Meters Arroceros Compound, covered by Transfer Certificate No. 51486.

On 23 May 2023, the City of Manila and JBros entered into an Amended Joint Venture Agreement (AJVA), superseding the 16 June 2017 JVA.

Under Section 5.1 of the AJVA, the city warrants that it will promptly issue all local licenses, permits, clearances, authorizations and approvals, which are necessary and required for the uninterrupted implementation of the Project in accordance with Section 6(h) of the JV Ordinance, provided that all requirements for their issuance under existing laws, ordinances and regulations are complied with by JBros. Section 6(h) of the JV Ordinance provides for Direct City Subsidy, which allows for tax exemptions in favor of the city's JV partners.

Through a letter dated 22 August 2023, JBros requested for the fulfillment of the city's obligation under Section 5.1 of the AJVA, for the exemption of payment of the city's transfer tax relating to the transfer of title to the Arroceros Compound from the city to Riverpark Central Corporation.

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Exemption from payment of the city's transfer tax and other incidental expenses relative to the transfer of title of that patrimonial property covered by Transfer Certificate of Title No. 51486, in the Registry of Deeds for the City of Manila, situated at Arroceros Compound, to be transferred to Riverpark Central Corporation, pursuant to the 23 May 2023 Amended Joint Venture Agreement, as requested by JBros Construction Corporation, is hereby granted and authorized, subject to existing laws, rules and regulations.

SEC. 2. Effectivity Clause. – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on sSeptember 5, 2023.
