WHEREAS, Dr. James G. Dy was born on December 9, 1931 in Manila, he was a prominent doctor, entrepreneur, philanthropist, and humanitarian worker. He made significant contributions to society in different capacities, including governor and national treasurer of the Philippine Red Cross;

WHEREAS, he used his wealth, which he acquired through diverse businesses in the electrical, travel, hotels, machines, and pharmaceutical industries, to give back to the people through his philanthropic activities;

WHEREAS, he stated that, "If you make something, you give it to society". A testament to his words can be seen in his relief operations with the victims of the 2019 earthquake in Porac, Pampanga, and in all other calamities in the country, Dr. James Dy has continued to extend a hand in providing relief and opportunities to his fellow Filipinos during his life;

WHEREAS, Dr. Dy refused to give up his humanitarian work. As the president of the Philippine Chinese Charitable Association, Inc. and the Chinese General Hospital and Medical Center, he remained actively involved in a variety of organizations. He continued to have a good impact on the lives of many people in need;

WHEREAS, over the course of his extraordinary 92-years of life, Dr. James G. Dy exemplified dedication to philanthropy and excelled in the world of business. His numerous achievements were complemented by his unwavering affection for his wife, Julieta Dy, and his children, the late Bella Dy Tan⁺, Jameson Dy, Howard Dy, Jennifer Dy Co, Kathleen Dy Go, and Sharon Dy Law, along with their spouses, grandchildren, and great-grandchildren;
