Lacson, Secretary to the Mayor, requesting for adoption of a resolution granting the Chief Executive of the city the authority to enter into a Memorandum of Agreement (MOA) relative to an in-house training of the Department of Engineering and Public Works (DEPW);


WHEREAS, the letter-request, together with the proposed Memorandum of Agreement was referred to the City Council for appropriate action;
