RESOLUTION DIRECTING THE MANILA TRAFFIC AND PARKING BUREAU, PARTICULARLY THE TRI-WHEEL MANAGEMENT UNIT SECTION, TO COMPILE A COMPLETE LIST OF THE OFFICIAL MEMBERS OF THE TRICYCLE OPERATORS AND DRIVERS' ASSOCIATION AND PEDICAB OPERATORS AND DRIVERS' ASSOCIATION IN THE ENTIRE CITY OF MANILA, INCLUDING A DETAILED ROSTER OF MEMBERS PER TRICYCLE AND PEDICAB, TO ENSURE PROPER REGULATION AND MANAGEMENT OF ROAD TRANSPORT SERVICES AND ENHANCE THE COLLECTION OF REGISTRATION FEES

WHEREAS, the City of Manila is committed to ensuring a safe, orderly, and efficient transportation system within its jurisdiction;

WHEREAS, the tricycle and pedicab is a significant mode of transportation, especially in providing short distance travel and serving routes which are not accessible to larger vehicles;

WHEREAS, the Tricycle Operators and Drivers' Association (TODA) and Pedicab Operators and Drivers' Association (PODA) play a vital role in ensuring the structured organization and operation of tricycle and pedicab services within the city;

WHEREAS, it has been observed there is a decline in the collection of registration fees from the members of TODA and PODA by the Tri Wheel Management Unit Section of the Manila Traffic and Parking Bureau (MTPB), which affects the city's revenue and the regulated operation of tricycles and pedicabs;

WHEREAS, having a comprehensive list of all official individual TODA and PODA members will aid not only in better regulation but also improves the efficiency of fee collection;

WHEREAS, the MTPB, particularly the Tri Wheel Management Unit Section is directed to:

- 1) Collaborate with respective TODAs and PODAs in the city to gather the necessary data of all their existing members;**
- 2) Create a detailed and comprehensive list of all official TODA and PODA members in the City of Manila, segregating the data per each TODA and PODA;**
- 3) Ensure the accuracy and completeness of the information gathered, including but not limited to the names, license numbers, and other pertinent details of TODA and PODA members;**
- 4) Utilize this data to revise strategies to enhance the collection of registration of fees from TODA and PODA members; and**
- 5) Submit a report detailing the progress of the compilation and the proposed strategies for improving fee collection to the City Council within a period of sixty (60) days from the approval of this Resolution.**


:NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to direct, as it hereby directs the Manila Traffic and Parking Bureau, particularly the Tri-Wheel Management Unit Section, to compile a complete list of the official members of the Tricycle Operators and Drivers' Association and Pedicab Operators and Drivers' Association in the entire City of Manila, including a detailed roster of members per Tricycle and Pedicab, to ensure proper regulation and management of road transport services and enhance the collection of registration fees; and be it FURTHER

RESOLVED, that a copy of this Resolution be furnished the Office of the Mayor, the Manila Traffic and Parking Bureau (MTPB), and all concerned Tricycle Operators and Drivers' Association (TODA) and Pedicab Operators and Drivers' Association (PODA).
