
WHEREAS, the CWC endeavors to improve the accessibility of child helpline services to the public nationwide, thereby strengthening its commitment to serve and protect children based on existing laws;

WHEREAS, the CWC pursuant to its mandate, developed the "MAKABATA HELPLINE" as a mechanism to provide immediate response, monitoring and feedback about matters relating to children's rights and concerns;

WHEREAS, the City Government of Manila, pursuant to its mandate under the Local Government Code to promote the general welfare of its constituents and discharge such other functions and responsibilities as are necessary, appropriate or incidental to efficient and effective provision of the basic services, agreed to partner with CWC for the adoption and implementation of the Makabata Helpline in the City of Manila: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to authorize, as it hereby authorizes the Honorable City Mayor, Maria Sheilah "Honey" H. Lacuna-Pangan, MD, FPDS, to sign and adopt the covenants in the Memorandum of Understanding between the City Government of Manila and Council for the Welfare of Children.
