WHEREAS, the IBRAHIM MOSQUE MUSLIM LEADER ORGANIZATION INC., with office address at Blk. 105 11th Street, Port Area, Manila, a duly registered organization with the Securities and Exchange Commission (SEC), is seeking accreditation as registered Non-Governmental Organization (NGO);

WHEREAS, IBRAHIM MOSQUE MUSLIM LEADER ORGANIZATION INC., aims to contribute in the upliftment and development of the quality of life, not only of the members, but also of the less fortunate members of the society, as well as launching various humanitarian and livelihood programs that are designed to promote self-reliance and economic independence;

WHEREAS, the Association's purposes are as follows:

- 1. To establish a foundation that will promote Muslim faith, culture and tradition;
- 2. To protect and preserve the environment;
- 3. To promote the moral, social and economic well-being of all members; and
- 4. To work with Non-Governmental Organizations in carrying out Government Programs and Projects;

WHEREAS, the same organization submitted the accomplished requisites and supporting documents for purposes of accreditation;

WHEREAS, after careful study and perusal of all the requirements submitted, it was established that it has all the qualifications to be accredited as a Non-Governmental Organization of Manila: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to grant, as it hereby grants the accreditation of Ibrahim Mosque Muslim Leader Organization Inc., to become an accredited Non-Governmental Organization of the City of Manila; and be it FURTHER

RESOLVED, that a corresponding Certificate of Accreditation be attached hereto and be issued to the said association; and be it FINALLY

RESOLVED, that copies of this Resolution be furnished the Department of the Interior and Local Government (DILG) and the NGO concerned.
