WHEREAS, he is a 68 years old Manileño who took and passed the Licensure Examination for Criminologists held on 25-27 August, 2023;

WHEREAS, Eugene Valiant Metica Cagas graduated from Our Lady of Lourdes Technological College Inc.;

WHEREAS, the Professional Regulation Commission (PRC) is a three-member commission linked to the Department of Labor and Employment (DOLE). Its mandate is to regulate and supervise the professional practice of the country's highly qualified manpower (excluding lawyers, who are handled by the Supreme Court of the Philippines);

WHEREAS, the PRC announces that five thousand seven hundred forty-three (5,743) out of seventeen thousand five hundred seventy-six (17,576) passed the Licensure Examination for Criminologists given by the Board of Criminology last August 2023 in thirty-one (31) testing centers all over the country;


