RESOLUTION GRANTING THE RENEWAL FOR ACCREDITATION OF ARRANQUE MARKET STALLHOLDERS DEVELOPMENT COOPERATIVE, AS AN ACCREDITED COOPERATIVE OF THE CITY OF MANILA

WHEREAS, the ARRANQUE MARKET STALLHOLDERS DEVELOPMENT COOPERATIVE, with office address at corner San Bernardo Street and C. M. Recto Avenue, Sta. Cruz, Manila, a duly registered organization with the Cooperative Development Authority (CDA) is seeking renewal of its accreditation;

WHEREAS, ARRANQUE MARKET STALLHOLDERS DEVELOPMENT COOPERATIVE, aims to contribute in the upliftment and development of the quality of life, not only of the members, but also of the less fortunate members of the society, as well as launching various humanitarian and livelihood programs that are designed to promote self-reliance and economic independence;

WHEREAS, the Association's purposes are as follows:

- 1. To engage in the procurement and distribution of commodities to members;
- 2. To establish, own, lease operate or manage public market;
- 3. To coordinate and facilitate the activities of the cooperative;
- 4. To engage in Electric Bill Collection to all Legitimate Stallholders of New Arranque Public Market
- To engage in lending business to all members of the Cooperative within its area of operation;
- 6. To actively support the government and other concerned organizations, both sustainable socio-economic development under a truly just and democratic society;
- 7. To provide goods and services to its members to enable them to attain increase income, savings, investments, productivity, and purchasing power, and promote among themselves equitable distribution of net surplus through maximum utilization of economies of scale, cost sharing and risk-sharing;
- 8. To avail of preferential rights granted to cooperatives under R.A. No, 7160, otherwise known as the Local Government Code, and other laws, particularly those in the grant of franchises to establish, construct, operate and maintain ferries, wharves, markets or slaughterhouses and to lease public utilities, including access to extension and on-site research services and facilities related to agriculture and fishery activities;
- To organize and operate schools in accordance to R.A. No. 9155 Governance of Basic Education Act of 2001 and other pertinent laws; and
- 10. To exercise such other powers granted by this Code or necessary to carry out its purpose or purposes as stated in its articles of cooperation;

WHEREAS, the same organization submitted the accomplished requisites and supporting documents for purposes of accreditation;

WHEREAS, after careful study and perusal of all the requirements submitted, it was established that it has all the qualifications to be accredited as a Cooperative of Manila: NOW, THEREFORE, be it



RESOLVED, by the City Council of Manila to grant, as it hereby grants the renewal for accreditation of Arranque Market Stallholders Development Cooperative, as an accredited Cooperative of the City of Manila; and be it FURTHER

RESOLVED, that a corresponding Certificate of Accreditation be attached hereto and be issued to the said association; and be it FINALLY

RESOLVED, that copies of this Resolution be furnished the Department of the Interior and Local Government (DILG) and the Cooperative concerned.
