RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF MANILA, REPRESENTED BY THE HONORABLE MAYOR MARIA SHEILAH "HONEY" H. LACUNA-PANGAN, MD, FPDS, AND THE CITY GOVERNMENT OF MALABON, REPRESENTED BY THE HONORABLE MAYOR, JEANNIE N. SANDOVAL, RELATIVE TO THE SECONDMENT OF THE PERMANENT EMPLOYEES FROM THE CITY GOVERNMENT OF MANILA TO THE CITY GOVERNMENT OF MALABON DULY CONCURRED BY THE SAME PERMANENT EMPLOYEES FOR A PERIOD OF TWELVE MONTHS, COMMENCING ON JULY 25, 2023 TO JULY 24, 2024, ENTERED IN THE BOOK OF NOTARIES OF ONE ATTORNEY REENA DEL B. WHEREAS, the City Government of Manila recognizes the need to strengthen linkages and collaboration with other local government units (LGUs), government agencies and institutions with the common goal of improving government services;

WHEREAS, Section 9, Rules VII of the Omnibus Rules Implementing Book V of Executive Order No. 292, also known as the "Administrative Code of 1987", includes secondment as one of the human resource movements allowed by law;

WHEREAS, Civil Service Commission Resolution No. 061165, Series of 2006, provides for the guidelines on secondment of employees occupying managerial, professional, technical or scientific positions;

WHEREAS, the City Government of Manila and the City Government of Malabon executed a Memorandum of Agreement regarding the secondment and concurrence of the following employees from the City Government of Manila to the City Government of Malabon for a period of twelve (12) months, commencing on July 25, 2023 to July 24, 2024:

WHEREAS, the City Government of Manila also stands to benefit from the secondment as the seconded employees seek to enhance their skills, knowledge, and expertise through exposure to different government agencies and institutions;

WHEREAS, the terms and conditions stipulated in the agreement are favorable to the City Government of Manila and its inhabitants: **NOW, THEREFORE, be it**

Sandoval, relative to the Secondment of the permanent employees from the City Government of Manila to the City Government of Malabon duly concurred by the same permanent employees for a period of twelve months, commencing on July 25, 2023 to July 24, 2024, entered in the Book of Notaries of one Attorney Reena Del B. Albaniel, a Notary Public for and in the City of Malabon, described as Document No. 90, Page No. 19, Book I, Series of 2023, duly executed on July 25, 2023 in the City of Malabon; and be it FURTHER
