
WHEREAS, Sub-section (a), Article 119 (Appointment of Appointive Local Officials) of the Rules and Regulations Implementing R.A. 7160 (Local Government Code of 1991), states that: *“unless otherwise provided in this Rule, heads of offices and departments in the LGUs shall be appointed by the Local Chief Executive concerned with the concurrence of a majority of all the members of the sanggunian, subject to civil service laws, rules and regulations”*;

WHEREAS, Section 4 of Republic Act No. 4196 vested the power to appoint the members of the Board of Regents to the mayor of the City of Manila with the consent of the Municipal Board, now the City Council;

WHEREAS, pursuant to the above-quoted provision of the Local Government Code of 1991, Her Honor, Mayor Maria Sheilah “Honey” H. Lacuna-Pangan, MD, FPDS, submitted to the City Council for concurrence the signed appointment of Mr. Joseph Berlin P. Juanzon, Ph.D as Member of the Board of Regents, Pamantasan ng Lungsod ng Maynila (PLM): NOW, THEREFORE, be it.

RESOLVED, by the City Council of Manila to manifest, as it hereby manifests the concurrence of the City Council of Manila to the appointment of Mr. Joseph Berlin P. Juanzon, Ph.D, as member of the Board of Regents, Pamantasan ng Lungsod ng Maynila, effective October 16, 2023 to October 15, 2029.
